YOU MUST BE REGISTERED TO BID.

Go to [Register for the Auto Auction \(deanstowningauction.com\)](http://deanstowningauction.com) to register. If applicable, have your Dealer License ID and expiration date ready.

Must be 18 years of age or older to bid.

WHEN DOES THE AUCTION START AND END?

Auction will start on Tuesday @ 10:00am and Closing will start @ 3:00pm. Lots will be extended for a period of time if bids have been placed upon closing of lot.

HOW TO BID?

Login to deanstowningauction.com review the list and place your bids.

WHAT IS THE STARTING BID?

Bids start at \$300; Floors are set @ \$300 fluctuating based on current scrap value.

WHEN CAN I INSPECT THE VEHICLES?

Vehicle Inspections are held the Monday prior to each auction start as follows:

Albert Lea, MN - 10:00am-3:00pm

Owatonna, MN - 10:00am-3:00pm

Faribault, MN - 10:00am-3:00pm

HOW WILL I KNOW IF I WON THE BID?

Since this is an open sale both buyers and sellers can see your bids. You will be sent an email no later than 24 hours after the end of the event notifying you of your winning bids. You can also login to deanstowningauction.com for a list of vehicles won.

HOW DO I PAY?

We accept **CASH ONLY**, accepted at the time of vehicle pick up.

Credit Card payments are accepted by pre-approved business arrangements only.

All vehicles will be assessed a buyer's fee. If additional fees are to be assessed, they will be listed in the auction lot details.

HOW SOON CAN I PICK UP MY CAR?

Vehicles won located at the Faribault location must be paid for and picked up the Friday following the end of the auction (3 business days) between 8:00am - 5:00pm.

Vehicles won located at the Albert Lea location must be paid for and picked up the Thursday following the end of the auction (3 business days) between 8:00am - 5:00pm.

Vehicles won located at the Owatonna location must be paid for and picked up the Friday following the end of the auction (3 business days) between 8:00am – 5:00pm.

During pick-up no repairs of any kind are allowed, including but not limited to: locksmiths, gas, battery installation, tire change, etc. If the vehicle won't start or cannot be safely driven, you must arrange for a tow. No exceptions.

Dean's Towing offers special rates for auction vehicles, inquire when making final payment.

WHAT IF I WON VEHICLES AT MULTIPLE LOCATIONS?

WHAT IF I DON'T PICK UP THE VEHICLE WITHIN THE REQUIRED TIME FRAME?

released. Name on title transfer must match Bill of Sale on file with Dean's Towing.
